# ARTICLES OF INCORPORATION

SECRETARY OF STATE The undersigned, for the purpose of forming a not for provide FLORIDA corporation pursuant to Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

## ARTICLE I. NAME
