## AMENDMENT TO ARTICLES OF INCORPORATION

SECRETARY OF STATE TALLAHASSEE, FLORIDA

OF

## USA/AFRICA INSTITUTE, INC.

The undersigned, as Executive Director of USA/Africa Institute, Inc. (the Corporation), amends the Articles of Incorporation of the Corporation, filed on March 6, 2002, as follows:

- 1. Article III. The following shall be included as paragraphs four and five to Article III:
  - 4. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the Corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
  - 5. Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

- 2. There are no members of the Corporation. This amendment has been adopted by all members of the Board of Directors of the Corporation by unanimous written resolution dated May 5, 2003.
- 3. Except as expressly amended herein, the Corporation's original Articles of Incorporation, filed on March 6, 2002, shall remain in full force and effect.


