In compliance with the requirements of Chapter 607 and 617 of the Florida Statutes for the formation of corporations not-for-profit, the undersigned hereby forms this corporation for the purposes herein specified.

I. NAME

The name of the corporation shall be Franklin County Literacy, Incorporated.

II. PRINCIPAL OFFICE
