ARTICLES OF INCORPORATION

The undersigned person of the age of eighteen (18) years or more, acting as incorporator of a not-for-profit corporation under Chapter 617, F.S., hereby adopts the following Articles of Incorporation for such corporation.

ARTICLE I

Name

The name of the Corporation shall be:

DECISION UNIVERSITY, INC.

ARTICLE II

Principal Office

ARTICLE III

Purpose

The purpose for which the Corporation is organized is to operate as a Non-denominational Christian Educational International University (a subsidiary corporation of Valley of Decision Ministries, MIVADE, Inc):

To engage in all lawful activities permitted by Florida Law for the conduct and operations allowed a Florida Non-Profit Corporation of Charitable, Social, Religious, and Educational purposes, and within the meaning of section 501(c) of the Internal Revenue Code.

“Notwithstanding any other provisions of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of the future U.S. Internal Revenue Law); or (b) by a organization contributions to which are deductible under section 1790(c)(2) of the Internal Revenue Code of 1986 (or corresponding provisions of any future United States Internal Revenue Law).

ARTICLE IV Manner of Election

DECISION UNIVERSITY, INC., is a member of Valley of Decision Ministries, (MIVADE) Inc, a qualifying not-for-profit religious organization, who shall have the right to appoint 2/3 the members of the Board, as set out in the bylaws of Valley of Decision Ministries, MIVADE Inc. The rest will be elected from the local academic community.

ARTICLE VIII
Number of Directors

The number of Directors of the Corporation shall not be less than three (3). However, the number of directors may be increased and decreased (but not to less than three members) from time to time in the manner set out in the bylaws of the corporation, and it shall not be necessary to amend these articles in order to increase or decrease the number of Directors. In no event shall the decrease of the number of the Board of Directors have the effect of shortening the term of any incumbent Director.

**ARTICLE IX
Indemnification**

The Corporation shall indemnify a person who was, is, or is threatened to be made a named defendant or respondent in a proceeding because the person is or was a Director or Officer of the Corporation in accordance with the provisions of the corresponding Florida statute, or for any other reason, or reasons for which Directors or Officers may be indemnified under the provision of the corresponding Florida law.

ARTICLE X

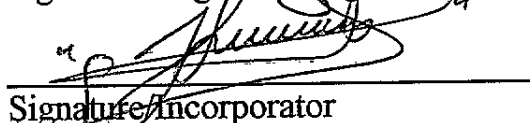
“Upon dissolution of this organization, the assets of the organization shall be transferred to the founding ministry “Valley of Decision Ministries, MIVADE, Inc.” and if it is not eligible, to another educational, religious, charitable, or other similar organization that is qualified as charitable organization under section 501(c)(3) of the Internal Revenue Code of 1986 or relevant section of any future Tax Code as amended.

Any such assets not so disposed shall be disposed by the court of Common Pleas of the County in which the principal office of the organization is then located exclusively for such purposes, or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purpose.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accepted the appointment as registered agent and agree to act in this capacity

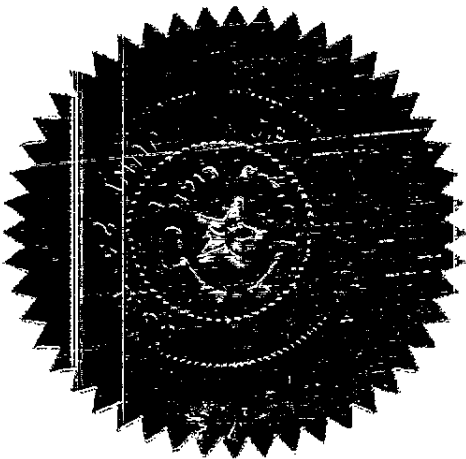

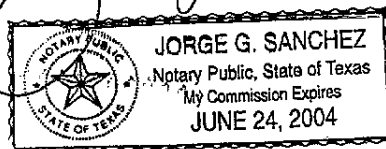
