**ARTICLES OF INCORPORATION**  
**OF**

**A Florida Not for Profit Corporation**

**ARTICLE I. NAME**

The name of this corporation shall be WOMEN'S HEALTH FOUNDATION, INC.

**ARTICLE II. PRINCIPAL OFFICE**

The mailing address and principal office of the Corporation is 1621 N. Mills Avenue, Orlando, Florida 32803.

**ARTICLE III. PURPOSE**

The purposes for which the Corporation is organized are the following:

A. To operate exclusively for charitable, educational, religious and scientific purposes as referred to in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

B. This Corporation is a not for profit Corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this Corporation is to support and assist, and to make grants and gifts in aid, and support and assistance of various charitable and health organizations and individuals. In carrying out such purpose, the Corporation shall have the power to exercise all rights conferred by the laws of the State of Florida upon nonprofit corporations.

**ARTICLE IV. BOARD OF DIRECTORS**

All corporate powers shall be exercised by or under the authority of, and the business of the Corporation shall be managed under the direction of, a Board of Directors. The number of Directors on this Corporation's Board of Directors shall initially be three (3) provided, however, that the number of Directors may be increased or decreased from time to time, as provided in this Corporation's Bylaws, but shall never be less than three (3) nor more than nine (9). Such Directors are to be elected or appointed in the manner provided for by the Corporation's Bylaws.

ARTICLE V. LIABILITY OF DIRECTORS

As fully as possible under the laws of the State of Florida as they now exist and as they may from time to time be revised, the Corporation intends that its Directors be protected from legal action by persons (natural or otherwise) on account of service as Directors of the Corporation. A Director shall not be liable for damages for actions of the Corporation to any person (natural or otherwise) unless such Director engaged in personal fraud affecting such action or actions of the Corporation.

ARTICLE VI. INITIAL REGISTERED AGENT AND STREET ADDRESS

The name and address of the individual who is currently serving as this Corporation's registered agent is R. Charles Curry, III, 489 Penny Lane, Maitland, FL 32751.

ARTICLE VII. INCORPORATOR

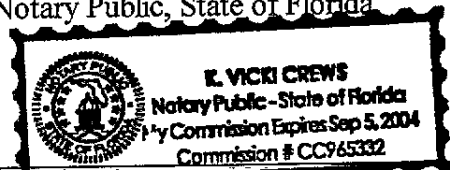
