The directors shall be elected in accordance with the by-laws.



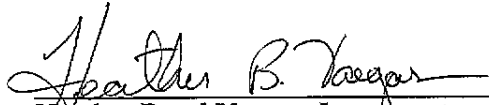

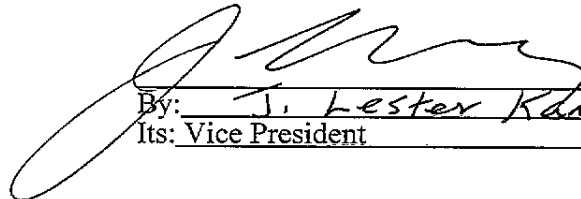
