Articles of Incorporation

The Country Club of Mount Dora Women's Club, Inc.

In Compliance with Florida Department of State, Division of Corporations, with Chapter 617, F.S., (Not for Profit).

Articles of Incorporation of the undersigned, a majority of who are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

Article I, Name: The name of the Corporation shall be The Country Club of Mount Dora Women's Club, Incorporated.

Article II, Principal Office: The principal place of business and mailing address of this corporation shall be: Toni C. Taylor, Registered Agent 9050 Laurel Ridge Drive Mount Dora, Lake County

Article III, Purpose: The purpose of this organization shall be to promote friendship and communication among the women of the Country Club of Mount Dora. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article IV, Manner of Election: The Nominating Committee shall be appointed by the President in March and shall present the name of one candidate for each office at the April meeting. Nominations may be made from the floor if the consent of the nominee has been obtained in advance. The election shall be held at the April meeting. Installation of new officers shall be in May. The terms of office shall run from June 1 through May 31.
