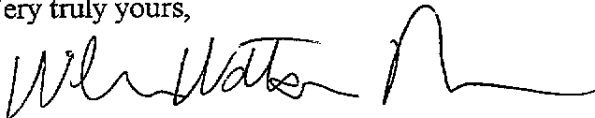

**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a Florida not-for profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE 1: CORPORATE NAME: The name of this corporation is **Nordic Relief Alliance, Inc.**

ARTICLE 2: PRINCIPAL OFFICE: The street address of the initial principal office and the initial mailing address of this corporation is 8125 NW 33 Street, Miami, Florida 33122.

ARTICLE 3: PURPOSE: The specific purposes for which this corporation is organized and shall be operated are exclusively for educational, charitable and religious purposes. Without limiting the generality of the forgoing, this corporation is organized and shall be operated as a Christian organization for the purposes of reduction of illiteracy in the world; education of the peoples of the world in the Christian faith and dissemination of the teachings of Jesus Christ; and the rendering of financial and relief assistance to the peoples of the world; thereby offering the peoples of the world the opportunity to learn of the teachings of Jesus Christ and the opportunity to believe in Jesus Christ as their Saviour.

ARTICLE 4: DIRECTORS: The corporation shall elect or appoint directors as set forth in the Bylaws.

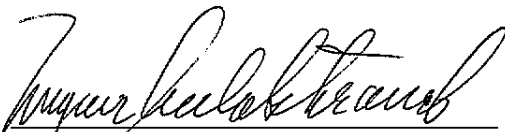
