- 3.2 Shall be conducted during the designated month by the Nomination and Election Committee with ballots sent to financially current members at the time of the election.
- 3.3 Shall be in accordance with the requirements of Article IV.

Shall be held in accordance with the requirements of Article IV, Section 6

APPOINTMENTS
