- 6. That the intention is to re-file the articles of incorporation correctly as a non-profit corporation.



ARTICLES OF INCORPORATION

OF

FOUNTAIN OF HELP FOUNDATION, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, and in Compliance with Chapter 617, F.S., (Not for Profit), hereby adopts the following Articles of Incorporation.

Article I - Name

The name of the corporation shall be:

FOUNTAIN OF HELP FOUNDATION, INC.

Article II - Principal Office

The principal place of business and mailing address of this corporation shall be:

715 Southwest 73rd Avenue Suite #4 Miami, Florida 33144

Article III - Purpose

The specific purposes for which the corporation is organized are:

- A. FOUNTAIN OF HELP FOUNDATION, INC. is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code).
- B. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate running for office.



Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

C. Upon dissolution of this corporation, assets shall be distributed for one or more exempt purpose within the meaning of Section 501(c)(3) of Internal Revenue Code, i.e. charitable, education, religious or scientific, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.

Article IV - Manner of Election

The manner in which the directors are elected or appointed:

Directors shall be elected by a majority vote of the remaining directors.
