ARTICLES OF INCORPORATION KOREAN-AMERICAN CHAMBER OF COMMERCE OF GREATER MIAMI, INC.

A Corporation Not For Profit

Article 1. NAME

The name of the corporation shall be Korean-American Chamber of Commerce of 1.1 Greater Miami, Inc.

. Article 2. INITIAL PRINCIPAL OFFICE

The initial principal office of the corporation shall be located at 8486 N.W. 18th Initial Principal Office Terrace, Miami, FL 33172.

Article 3. PURPOSES

- The corporation is for the following purposes: 3.1
 - 1. To promote reciprocal and mutually beneficial business and economic links between Korean-American communities living in South Florida.
 - 2. To foster enhanced understanding of Korean business practices, culture and traditions in the South Florida community.
 - 3. To conduct programs and events designed to further the friendly relations and mutual opportunities that exist between the Republic of Korea and the greater South
 - 4. To facilitate information on business and investment opportunities in the Republic of Korea to the South Florida community.

Article 4. MEMBERS

Qualifications for general membership Membership shall be open to any and all persons demonstrating an interest in 4,1

promoting the purposes and objectives of the organization and in participating in its activities. To become an active member, an organization or individual must be recommended for membership by at least one Active Member. New members will be approved by a majority of the Officers of the Chamber.

The Board of Directors may establish other categories of membership including, but Special Member: not limited to, Ex Officio and Honorary membership at its discretion.

4.3

Board of Directors shall determine the dues for each type of memberships. Dues

Article 5. MEETING OF THE MEMBERS

5.1

The Board of Directors shall determine the date of each annual meeting of the members.

5.2

The special meeting of the members shall be called by the President (1) when he or she deems it necessary, (2) when requested by the Board of Directors, (3) when more than one-third of the members request such a meeting.

Article 6. BOARD OF DIRECTORS

Number and Terms 6.1

The Board of Directors shall have 15 members with 3 year terms. However, onethird of the initial board members shall have 1 year term and another one third of the initial board members shall have 2 year term.

Election of Directors 6.2

At every annual members' meeting, elections for the vacancies of the Board of Directors will be held. Only Active dues paying members are eligible on the Board of Directors.

Article 8. EXECUTIVE DIRECTUR

8,4 Executive Director

The Board of Directors may appoint an Executive Director who will serve at the Board of Director's pleasure. Executive Director will have broad administrative powers and responsibilities to manage the day-to-day affairs of the corporation. Executive Director will not be an Officer or member of the Board.

Article 9. NO DISTRIBUTION OF EARNINGS TO MEMBERS

9.1 No part of the net carnings of the corporation shall inure to the henefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof.

Article 10. AMENDMENT

10.1 These Articles of Incorporation may be amended, modified, or repealed by the three-fifth (3/5) vote of the Board of Directors.

Article 11. BYLAWS

11.1 The initial bylaws of the corporation shall be adopted by the Board of Directors. The power to alter, amend, repeal, or adopt new bylaws shall be vested in the Board of Directors.

Article 12. REGISTERED AGENT AND REGISTERED OFFICE

12.1 The initial registered office shall be located at 1550 Madruga Avenue, Suite 415, Coral Gables, FL 33146 and the name of the initial registered agent is Chie-Young Chyung.
