We, the undersigned residents of the State of Florida, being eighteen (18) or more years of age, do hereby associate ourselves together for the purpose of forming a corporation not for profit, under the laws of the State of Florida, pursuant to the following Articles of Incorporation:

**ARTICLE I**

**Name**

The name of this corporation is: **LIVING CENTERED, INC.**

**ARTICLE II**

**Principal Office**

The mailing and street address of the principal office of the corporation is 4725 North Courtenay Parkway, Merritt Island, Florida 32953. The name of the initial registered agent of the corporation at that address is Diane Winston.

**ARTICLE III**

**Statement of Corporate Nature**

This is a corporation not for profit organized for charitable and religious purposes, including, but not limited to, the facilitation of balanced and joyful living at home, at work and in the community through mind-body-spirit wellness, unity in diversity, and the appreciation of the freedom and abundance in our lives by providing educational programs, outreach services, cultural activities, therapy, research opportunities and support groups, pursuant to the Florida Not For Profit

Corporation Act set forth in Chapter 617, *Florida Statutes*.

#### **ARTICLE IV**

##### **Duration**

The period of duration of this corporation not for profit shall be perpetual.

#### **ARTICLE V**

##### **General and Specific Purposes**

The specific and primary purposes for which this corporation is to conduct educational benevolent, therapeutic, scientific purposes and to be involved with other religious and charitable activities consistent with a not for profit corporation under the laws of the State of Florida, including but not limited to the right to buy, sell, and mortgage real and personal property, make investments and seek donation for its support.

#### **ARTICLE VI**

##### **Member Corporation**

This corporation shall be a non-member corporation.

#### **ARTICLE VII**

##### **Non Stock Corporation**

This corporation shall be non stock and no dividends or pecuniary profits shall be declared or paid to anyone.

### **Amendment to Articles**


The Articles of Incorporation may be amended by a majority vote of the Board of Directors.




