SECOND: The Articles of Incorporation were filed on March 13, 2002. The document number of the corporation is N02000001824 and the Employer Identification number is 75-3026206.


THIRD: Adoption of Dissolution:

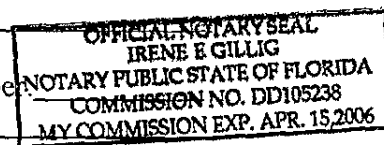
