**1. ARTICLE IX. COUNCIL OF ELDERS; ELDERS/PASTORS; DEACONS:**

Section 4. The senior Pastor is the Overseer of the church and shall direct all

The corporation and shall perform duties of the church and the Council of Elders. He/She

shall be an ex-officio member of all special meetings, conventions, or revival

campaigns. No person shall be invited to speak or preach in the church without

His/her approval. In case of resignation or expiration of the Senior Pastor, the Co-

Pastor or next in line of authority shall assume pastorate. The new pastorate shall be

placed in position with consultation of the Trustees, Board of Elders and if in affiliation

the General overseer/ Apostle/ Bishop.

**2. ARTICLE X. BY LAWS**

**ADMMENDED: ARTICLE XI. BY LAWS**

The Council of Elders shall provide such by-laws for the conduct of its business

and business of the Church as the Council may deem necessary from time to time. Such  
by-laws may be amended, altered, or rescinded, by a majority vote of the Elders present  
at any regular meeting or any special meeting called for that purpose.

**3. ARTICLE XI. AMENDMENTS**

**AMENDED: ARTICLE XII. AMENDMENTS**

These Articles of Incorporation may be amended at any special meeting of the  
Council of Elders called for that purpose, or at any regular meeting of the Council;  
provided, however, that notices of the fact that an amendment to the Articles of  
Incorporation is to be considered shall be given in writing to the ruling Elders at least one  
week prior to the date of such meeting. Upon adoption by the Council of Elders, and  
upon filing with the Secretary of the State of Florida, the amendment shall become  
effective as to these Articles of Incorporation shall ever conflict with the purposes and  
powers of this Church as set forth in Articles III and IV hereof.

**4. ARTICLES XII. DISSOLUTION**

**AMENDED: ARTICLE XIII. DISSOLUTION**

This corporation may be dissolved only pursuant to the agreement of two-thirds  
(2/3) of the full Council of Elders. In the event of such dissolution, the Council of Elders  
with consultation of the General Overseer/ Apostle/Bishop if so affiliated after paying or  
making provision for payment of all of the liabilities of the corporation, dispose of all of  
the assets of the corporation exclusively for the purposes of the corporation in such  
manner, or to such organizations organized and operated exclusively for charitable,  
educational, religiously or scientific purposes as shall at the time qualify as an exempt  
organization under section 501(c) (3) of the Internal Revenue Code of 1954 (or the  
corresponding provision of any future United States Internal Revenue Law), as the  
Council of Elders shall determine. Any of such assets not so disposed of shall be

disposed of by the Circuit Court of Leon, County, Florida, if the principal office of the corporation, or by the Circuit Court (or equivalent thereof) of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as the said Court shall determine, which are organized and operated exclusively for such purposes.
