ARTICLES OF INCORPORATION OF
THE CENTRAL FLORIDA PART C REGIONAL POLICY COUNCIL CORP.

The undersigned hereby form a corporation organized under the laws of the State of Florida by and under the provisions of the statutes of said state providing for the formation, liability, rights, privileges, and immunities of a corporation and hereby forms this corporation not for profit.

ARTICLE I

The name of this corporation is:
THE CENTRAL FLORIDA PART C REGIONAL POLICY COUNCIL CORP.

ARTICLE II

ARTICLE III

This corporation is to have perpetual existence. The existence of this corporation shall commence when the Articles of Incorporation have been filed with the Department of State and shall have perpetual duration unless sooner dissolved according to law.

ARTICLE IV

The purpose for which this corporation is organized is to be a non-profit organization aiding and effecting the requirements of state law for this Regional Policy Council. In addition, this corporation is authorized to engage in all other acts or conducts and activities for which corporations not for profit may be organized under the laws of the State of Florida.

ARTICLE V

Any adult resident of the State of Florida who is accepted by a majority vote of the official members of the Central Florida Part C Regional Policy Council corporation may become a member of the corporation. Additional provisions regarding the qualifications of membership in this corporation may be stated or regulated by the by-laws of this corporation.
