Articles of Incorporation
of
Coconut Grove Collaborative, Inc.

Article I - Name

The name of this not for profit corporation shall be:

COCONUT GROVE COLLABORATIVE, INC.

Article II - Principal Office

The address of the principal office, as well as the mailing address of the corporation shall be
3640 Grand Avenue, Coconut Grove, Florida 33133.

Article III - Purpose

The purposes for which the corporation is organized are exclusively charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code (IRC) of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these article, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Article IV - Membership

Membership in the Coconut Grove Collaborative will consist of IRC Section 501(c)(3) organizations, religious organizations, neighborhood groups and other recognized non profit organizations located in or doing work in the targeted area of Coconut Grove, Florida.

Article V - Manner of Electing Directors

The corporation will be managed by a board of directors and officers to be elected by the membership of the Coconut Grove Collaborative for one year terms. The method of electing directors and officers shall be further stated in the bylaws of the corporation.

Article IX - Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purposes. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
