## ARTICLES OF INCORPORATION OF

GARDENS INDUSTRIAL PARK CONDOMINIUM ASSOCIATION, INC.
A FLORIDA CORPORATION NOT FOR PROFIT

The undersigned incorporators by these articles associate themselves for the purpose of forming a corporation not for profit under the laws of the state of Florida, and adopt the following articles of incorporation:

#### ARTICLE I. NAME AND ADDRESS

The name of this corporation is GARDENS INDUSTRIAL PARK CONDOMINIUM ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "association," these articles of incorporation as the "articles," and the bylaws of the association as the "bylaws."

#### ARTICLE II. TERM OF EXISTENCE

The association shall have perpetual existence.

#### ARTICLE III. PURPOSE
