ARTICLE I
Corporate Name

The name of this corporation is **CAMPERDOWN HIGH SCHOOL PAST STUDENTS' ASSOCIATION, FLORIDA CHAPTER, INC.**

ARTICLE II
Corporate Nature

This is a nonprofit corporation organized pursuant to the corporation's Not for Profit Law of the State of Florida, set forth in Part One of Chapter 617 of the Florida Statutes.

ARTICLE III
Duration

This corporation shall have perpetual existence.

ARTICLE IV (Amended)
General and Specific Purposes

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future tax code).

- a. The specific and primary purpose for which this Corporation is organized is to promote and enrich the academic, cultural, philosophical, social, and physical development of Camperdown High School.
- b. To form a bond between the institution (its students, teachers, and administrators) and past students.
- c. To produce opportunities and facilities for fellowship between Camperdown past students, their families, and friends of Camperdown.
- d. This Corporation is organized to achieve all of the above through the conception, implementation and careful supervision of social and fund raising projects and other nonprofit purposes, and no part of any net earnings shall inure to the benefit of any member, director or officer.

ARTICLE VII
Activities Prohibited

No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding section of any future federal tax code) or (b) by a corporation, contributions to which are deductible under section 170(c)(3) of the Internal Revenue Code of 1954 (or corresponding section of any future federal tax code).

ARTICLE VIII
Membership

The qualifications and manner of admission of members of this Corporation, the property, voting and other rights and privileges of members, the liability of members for dues or assessments and the method of collection thereof and the termination of membership shall be as set forth in the bylaws of the corporation.

ARTICLE IX
Member Liability

The private property of this Corporation's members, directors or officers shall not be subject to the payment of Corporation debts to any extent whatsoever.
