ARTICLES OF INCORPORATION
OF**ROYAL BLUE SUPPORT SERVICES, INC.**

A Corporation Not for Profit

THE UNDERSIGNED, acting as incorporation of a corporation under Chapter 617, Florida Statutes, Corporations Not for Profit, adopts the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation shall be ROYAL BLUE SUPPORT SERVICES, INC.

ARTICLE TWO

The purpose for which the corporation is organized is to provide support services to person with disabilities at the lowest possible.

ARTICLE THREE

Any person shall be admitted as a member upon paying the annual dues, if any as set by the Board of Directors.

ARTICLE FOUR

The corporation shall have perpetual existence.

ARTICLE FIVE

The corporation shall be managed by its President, Vice President, and Secretary. The officers shall be elected by the Board of Directors. Elections shall take place annually or at such time as a vacancy occurs.

ARTICLE SIX

The By-laws of the corporation are to be made, altered, and rescinded by the Board of Directors

ARTICLE ELEVEN

These articles of Incorporation may be altered, rescinded or adopted by a majority vote of the Board of Directors.

In the event of dissolution the residual assets of the corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c) (3) and 170 (c) (2) of the Internal revenue Code of 1954 or corresponding Sections of any prior or future law, or to the federal, State or Local government for exclusive public purpose.

ARTICLE FOURTEEN

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal Income Tax under Section 501(c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law or (b) a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Law.

ARTICLE FIFTEEN

Notwithstanding any other provision of these Articles, these purposes are limited to those ascribed in Section 501 (c) (3) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal revenue Law.
