

AMENDMENT TO ARTICLES OF INCORPORATION OF THE FRIENDS OF BOCA CIEGA MILLENNIUM PARK, INC. A FLORIDA NOT FOR PROFIT CORPORATION

We the undersigned the duly appointed officers of the Friends of Boca Ciega Millennium Park, Inc., hereby certify that the Board of Directors in accordance with Section 617, Florida Statutes, adopted and approved the following Amendment to Article of Incorporation.

<u>AMENDMENT</u>

The following paragraph shall be substituted for Section 1 of Article IV:

Section 1. Number, manner of selection and term of office: The Board of Directors (hereinafter referred to as "Board") shall consist of the four officers of the Corporation, who shall also be directors, and no more than nine additional elected directors and. The elected directors shall be elected by the general membership at the annual meeting. The elected directors_shall serve for a term of one year and thereafter until their successors are elected.

In all other respects the Article of Incorporation shall remain as they were prior to this amendment being adopted. This amendment was unanimously adopted by the Board of Directors on November 16, 2002. There are no members or members entitled to vote on this amendment.
