ARTICLES OF INCORPORATION

OF

Project TeamQuest, Inc.

A NON-PROFIT CORPORATION

The undersigned incorporator(s), in order to form a non-profit corporation Pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ONE: The name of this corporation shall be:

Project TeamQuest, Inc.

TWO: The principal place of business and mailing address of this corporation shall be:

THREE: The specific purposes for which this corporation is organized are: 1) to offer educational programs and materials to the general public which promote one or more of the following skills: teamwork, innovation, problem solving, self-confidence, group-confidence, communication, leadership and followership; 2) to assist other groups engaged in similar activities; and 3) to engage in other pursuits incidental to an operational center of learning.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

**FOUR:** Members of the Board of Directors of this corporation shall be elected by ballot of the current board as specified in the bylaws of this corporation.

**FIVE:** The number of initial directors of this corporations is 3. Their names and address are as follows:

**EIGHT:** The period of duration of this corporation is perpetual.

**NINE:** The membership provisions of this corporation shall be stated in the Bylaws of this corporation.

**TEN:** Any additional provisions for the operation of the corporation are as follows:

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

The undersigned incorporators hereby declare under penalty of perjury that the statements made in the foregoing Articles of Incorporation are true.
