# ARTICLE I. CORPORATE NAME

The name of this corporation is SOUTH FLORIDA ATHLETIC CLUB INC.

### ARTICLE II. PRINCIPLE OFFICE

ARTICLE HI.GENERAL PURPOSE OF THE CORPORATION
