The undersigned incorporator, for the purpose of forming a corporation under Florida Not-For-Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be: BARRIER FREE ACCESS 4 ALL, INCORPORATED.

**ARTICLE II
PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 1440 Northeast 50th Court, # 2, Fort Lauderdale, Florida 33334.

**ARTICLE III
PURPOSE**

The specific purpose for which the corporation is organized is to engage in advocacy activities on behalf of individuals with disabilities and its members to assure that those individuals and/or entities required to comply with the provisions of the Americans With Disabilities Action fulfill their obligation under the Americans With Disabilities Act so that all persons, including those with disabilities, can have access to all places of public accommodations, commercial facilities and service establishments and have full and equal enjoyment of the goods, services, facilities, privileges, advantages and accommodations offered therein.

The manner of which the Directors are elected or appointed is pursuant to the By-Laws of this corporation.




