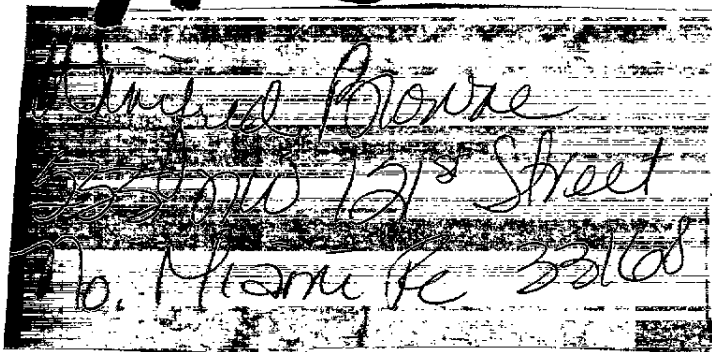

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Non-profit Corporation under Chapter 617 of the Florida Statutes.

**ARTICLE 1 – NAME**

The name of the Corporation is **W A L NATIONAL FAITH BASED CHAMBER OF COMMERCE, INC.**, (hereinafter, "Corporation"). The address is 555 NW 121<sup>st</sup> Street, North Miami, FL 33168.

**ARTICLE 2 – PURPOSE OF CORPORATION**


This Corporation is a non-profit Public Benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Non-profit Public Benefit Corporation Law for, charitable and educational purposes, to aid poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but shall not be limited to Job Training Job Placement, Land Acquisition, Housing, Employment, Literacy, Counseling, temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring, AIDS, Elderly Care and other programs to aid to those in need. Also catering primarily to non profit organizations provides economic and empowerment solutions to communities, businesses and individuals by promoting workshops, grant writing classes and program implementation for community restoration.

**ARTICLE 3 – TERM OF EXISTENCE**

The duration of this corporation shall be perpetual, no stock and shall have no members.

#### **ARTICLE 4 – REGISTERED OFFICE AND REGISTERED AGENT**

#### **ARTICLE 5 –**

(a) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501©3 of the Internal Revenue Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501©3 of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170©2 of the Internal Revenue Code.

#### **ARTICLE 6 –**

The property of this corporation is irrevocably dedicated to Charitable and Educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

#### **ARTICLE 7 –**

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts, and liabilities of this corporation, shall be distributed to a non profit fund, foundation, or corporation, which is organized and operated exclusively for, Educational and Charitable under Section 501©3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a

public purpose. Any such asset not disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


#### ARTICLE 8 – DIRECTOR(S)




