**Articles of Incorporation**

**Article I  
Name**

The name of the Corporation is:

**Project Refuge Homeless Shelter 2 Psalm 91 CORP.**

**Article II  
Principal Office**

The principal office of the Corporation shall be at 1316 Amanda Street, Altamonte Springs, Florida 32701. The mailing address of the Corporation shall be at 1316 Amanda Street, Altamonte Springs, Florida 32701.

**Article III  
Purpose**

The purposes for which the Corporation is formed are the following:

(A) The Corporation is organized exclusively for charitable and not for profit purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986, as amended (the "code"), including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the code (or the corresponding provision of any future United States Internal Revenue Law) including without limitation, organizations devoted to health, rehabilitation, charitable, educational, religious, scientific or literary purposes and the holding, ownership and/or management of real and personal property for the exclusive benefit of such qualifying organizations.

(B) This Corporation is not organized and shall not be operated for pecuniary gain or profit. No part of the property or net earnings of the Corporation shall inure to the benefit of or be distributable to its directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in article III hereof. The Corporation shall not carry on propaganda, or otherwise attempt to influence legislation to such extent as would result in loss of its exemption from federal income tax under section 501 (c)

(3) of the code, and the Corporation shall not participate in, or intervene in (including publication or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the code (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the code (or the corresponding provision of any future United States Internal Revenue Law).

#### **Article IV**

##### **Manner of Election**

The affairs of the Corporation shall be managed by a Board of Directors. The number of directors of the Corporation and method of election shall be set out in the bylaws.

No director shall have any personal liability to the Corporation or its members for monetary damages for breach of duty omission occurring subsequent to the date when this provision becomes effective, except that this provision shall not eliminate or limit the liability of a director for (a) any appropriation, in violation of his duties, of any business opportunity of the Corporation; (b) acts or omissions which involve intentional misconduct or a knowing violation of law; (c) liability of a director imposed by section; or (d) any transaction from which the director derived an improper personal benefit.
