The undersigned acting as incorporator(s) of a Corporation pursuant to Chapter of Florida Statutes, adopt(s) the following Article of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be:

**The principal place of business of this corporation shall be:

ARTICLE II

The period for this corporation is Perpetual "Filing with the Secretary of State" unless dissolved according to law and shall engage in any activity or business permitted a non-profit entity under the laws of the United State and of the State of Florida.

ARTICLE III

The purpose (purposes) for which the corporation is organized is (are): This is a non-stock, non-profit corporation. The purpose for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United State of Internal Revenue law. Said corporation is organized exclusively for charitable, religious, and educational purposes including . for such purposes, the making of distribution to organizations that qualify as exempt organization under Section 501 (c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United State Internal Revenue law. Notwithstanding any other provision of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United State Internal Revenue law.

ARTICLE ^{IV}~~VI~~

The corporation is organized under a non- stock basis.

In the even of dissolution, the residual assets of the organization will be turned over to one or more organization which themselves are exempt as organization described in Section 501 (c)(3) and 170(c)(2) of the Internal Revenue Code 1954 or corresponding sections of any prior or future law, or to Federal, State, or Local Government for exclusive public purpose.

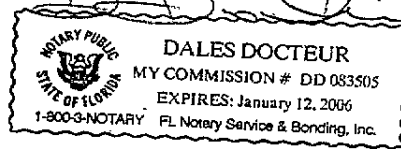
