**ARTICLES OF INCORPORATION
OF
PARADISE FOR ANGELS LEARNING CENTER**

THE UNDERSIGNED, as incorporator and on behalf of a not-for-profit, non-stock corporation under the laws of Chapter 617 of the State of Florida, hereby adopts the following Articles of Incorporation;

ARTICLE I

The name of the corporation is: PARADISE FOR ANGELS LEARNING CENTER, INC., and its principle address is: 12610 SW 7TH PLACE, DAVIE, FL 33325.

ARTICLE II

The Corporation shall have perpetual existence unless dissolved pursuant to law.

ARTICLE III

The Corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE IV

This Corporation shall have a membership consisting of the Board of Directors of the Corporation serving from time to time.

ARTICLE V

The affairs of the Corporation shall be governed by a Board of Directors (hereinafter referred to as the "Board"), subject to the restriction that, except as specifically set forth to the contrary in the Bylaws, the exercise of any powers of actions of the Board shall require the approval thereof by a majority vote of the Board present at a meeting at which a quorum of no less than (2) Directors are present. The affirmative vote of any two (2) Directors shall be necessary for all corporate action requiring a vote of the Board, including, but not limited to the following:

a. Approval of charitable gifts, transfers, distributions and grants by the Corporation to other entities.

b. Adoption of amendment to the Articles of Incorporation or Bylaws.

ARTICLE VI

The initial Board of Directors shall consist of the following members:
