ARTICLES OF INCORPORATION

for

I, the undersigned, acting as the Incorporator, for the purpose of organizing a corporation pursuant to the Florida Not For Profit Corporation Act of the State of Florida, do hereby certify as follows:

ARTICLE I

The name of this corporation is:

ARTICLE II

The period of its duration is perpetual, beginning from the date these Articles are filed with the Department of State:

ARTICLE III

This organization is a non-profit corporation organized and operated exclusively for exempt purposes within the meaning of Section 501(c)(3) and 170 (c)(2) of the Internal Revenue Code of 1954, as amended, including the following purposes taken from the Bible:

- a. Feed the Hungry
- b. Clothe the Naked
- c. Set the Captives Free
- d. Bring hope to the Broken Hearted
- e. Preach the glorious Gospel of Jesus Christ
- f. Offer Salvation to the Lost

as well as any other mandates given by our Father.

(or the corresponding provision of any future United States Internal Revenue Law); or by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).

The Board of Trustees may cause the corporation to solicit, collect, receive, accumulate, administer and disburse funds in such manner as will, in the sole discretion of the Board of Trustees, most effectively operate to further the purposes of the corporation.
