A CORPORATION NOT-FOR-PROFIT

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be: GATEWAY BAPTIST ASSOCIATION TUTORIAL AND MENTORING PROGRAM, INC.,
(hereafter referred to as the "Program.")

ARTICLE II. PURPOSE

The purpose of the program is to provide quality tutorial and mentoring services that will enrich the lives of families which will reduce risk factors and allow each participant to reach their full potential at school and within the community. The goal is to increase academic performance of participants, increase school attendance, reduce school discipline by incorporating home counseling and reduce violence committed by youths.

The utilization of biblically-based methodology in research, counseling, and professional approaches to healing and ministering to the body, mind, and spirit. The program is

committed to teach and spread the Gospel of Jesus Christ. The program is open to anyone who is interested in enrolling and does not discriminate against race, sex, or national origin.

ARTICLE III. OFFICES AND AGENCY

The principal place of business of this program shall be 1841 West 3rd St. Jacksonville, Florida 32209.

ARTICLE IV. TERM OF EXISTENCE

Commencing on March 25, 2002, the Program shall have perpetual existence.

ARTICLE V. MEMBERSHIP

Pursuant to the Bylaws, membership in, and services offered by the Program are open to all individuals, on a non-discriminating basis.

ARTICLE VI. BOARD OF DIRECTORS

The business affairs of the program shall be managed by the Board of Directors. The Board of Directors shall be elected by the members of the program from among the membership at the annual membership meeting as provided in the Bylaws. The number of the members of the first Board of Directors shall be six. ARTICLE VII. BYLAWS

The Board of Directors shall adopt by a majority vote of the original Bylaws of the Program.


