ARTICLES OF INCORPORATION AND ORGANIZATION 02 MAR 22 PM 4: 28

Articles of Incorporation of the undersigned, citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

- Article I: The name of this corporation shall be **SOUNDTRAX A CAPPELLA SINGERS, INCORPORATED.**
- Article II: The principal place of business and mailing address where this corporation is to be located is **119-D Weybridge Circle, Village of Royal Palm Beach, Palm Beach County, Florida, 33411.**
- Article III: The specific **purposes** for which this corporation is organized and its **limitations** are to conform with the definitions and limitations of **Section 501(c) 3 of the Internal Revenue Code** as follows:
1. Charitable purposes.
  2. Educational purposes.

The mission of the **SOUNDTRAX A CAPPELLA SINGERS, INCORPORATED** vocal group is to musically educate volunteer citizens from our local community to provide high-quality a cappella musical entertainment for various community events. This is achieved by teaching volunteer members singing dynamics, proficient harmonization, and the self-confidence to perform publicly with only their voices. The members donate their time learning and performing in their community. This group performs for local charitable and civic events in the spirit of volunteerism. By sharing their musical talents, they are able to bridge social and cultural differences, bringing people of diverse backgrounds together in a common undertaking.

- Article IV: The initial Corporation Directors are the founders of the group as listed in Article V. Upon the circumstance of vacancies, volunteers will be solicited and selected from within the current membership of the group by the Directors.

Article VIII: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this organization.

Article IX: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)3 of the Internal Revenue Code to the choral music program of Royal Palm Beach High School, Royal Palm Beach Florida, for public purposes.

Article X: The effective date of these Articles of Incorporation is: March 25, 2002.

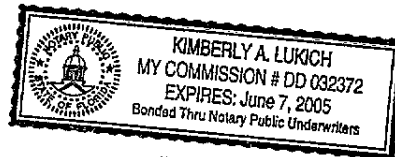
