We, the undersigned subscribers to the Articles of Incorporation, each a natural person, competent to contract, hereby make, subscribe, acknowledge and file these Articles for the purpose of becoming a Corporation not for profit pursuant to Chapter 617.0202, Florida Statutes.

ARTICLE I: NAME

The name of the corporation shall be King Cobra Enterprise, Inc.

ARTICLE II: PLACE OF BUSINESS

The principal place of business shall be in the County of Hillsborough, State of Florida as determined by the Board of Directors. The mailing address is: 109 Rosana Drive-Tampa, Fl-33511.

ARTICLE III: PURPOSE

The purpose for which this corporation not for profit is organized are as follows:

1. To develop innovative prevention programs to aid in crime prevention within the inner-city community.
2. To develop programs that with assist juveniles released from incarceration adjust back to the community.

3. To provide a venue for youths to utilized there skills in the areas of boxing, physical fitness, music, poetry, fashion and entertainment.

4. To provide an opportunity for individuals to display their talent through entertainment venues.

5. To provide an outlet for inner-city kids to have an opportunity to developed interpersonal skills and self-awareness training.

ARTICLES IV: BOARD OF DIRECTORS

The Board of Directors shall consist of not less than five(5) and no more than eleven(11) individuals from the community.

The Board of Directors shall be elected at the annual meeting of the directors and each directors shall hold office for a term of two(2) years and until his or her successor is duly elected and qualified or until his or her death, resignation or removal.

Each person named in the Articles of Incorporation as a member of the initial Board of Directors shall hold office for an initial term of two(2) years and until his or her successor shall have been elected and qualified or until his or her earlier resignation, removal from office or death.

ARTICLE V: REGISTERED AGENT

The registered agent of this corporation shall be Corey Felton, 109 Rosana Drive, Brandon, Florida 33511.

ARTICLE VI: TERM OF EXISTENCE

This corporation not for profit shall have perpetual existence.

ARTICLE VII: OFFICERS

The officers of the corporation shall be the Chairman, Vice-Chairman, Secretary and Treasurer and other officers as provided by the By-laws.

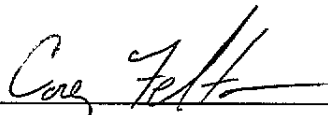
ARTICLE VIII: BY-LAWS

ARTICLE IX: SUBSCRIBERS

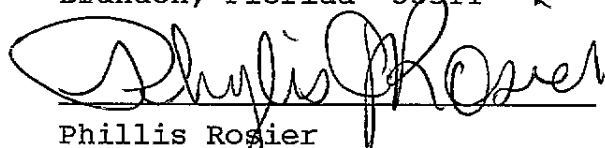
