The undersigned Florida nonprofit corporation pursuant to chapter 617.1006, Florida Status, adopts the following Articles of Incorporation:

ARTICLE I Name

The name of the corporation shall be called The Oasis of Jacksonville, Inc.

ARTICLE II

Principal place of business and mailing address

The principal place of business and mailing address of the incorporation shall be:

ARTICLE III Purpose(s)

The specific purposes for which the corporation is organized are:

The Oasis of Jacksonville is organized exclusively for charitable, educational, and scientific purpose within the meaning of section 501c3 of the Internal Revenue Service Code of 1986, or the corresponding provision of any future United States Internal Revenue Law. Under these provisions, this organization shall carry on the business f running independent living facility for the elderly.

Article IV Manner of election of directors

Manner in which the directors are elected is as follows: The method of election of the directors shall be stated in the bylaws.

ARTICLE V Limitation of activities

No part the net earnings of the corporation shall inure to the benefit of, or be distributable to, any director or officer of the corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation, or any other private individual, shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation; provided, how4eever, the corporation may confer benefits in the form of distributions, in dissolution or otherwise, upon any nonprofit corporation described in section 501 c 3 and section 170C (2) of the code and specified in paragraph 3 below. No substantial part of these activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall participate in or intervene in any political campaign (including the publication or distribution of statements) on behalf of any candidate for public office.

Notwithstanding any other provisions of these articles of incorporation the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an or exempt from taxation under section 501 c 3 of the code, or by an organization receiving contributions deductible under section 170 C (2) of the code.

ARTICLE VI

Upon the dissolution of the corporation, any assets after paying or making provisions for the payment of the liabilities of the corporations shall be distributions shall be distributed to such organization or organizations organizes and operated exclusively for charitable, educational religious or scientific purpose at which, at the time of such disposition, qualify as an exempt organizations o organizations under section 501 c 3, section 170 c 2, and section 509 (a) (1) or (2) of the internal revenue code of 1986 or corresponding sections of any or future internal revenue code by reason of such organization or organizations providing public services, or to the federal, state, or local government for an exclusive public purpose. Any assets not disposed of shall be disposed of by a curt of competent jurisdiction exclusively for such charitable purposes, or to such organizations organized and operated exclusively for such charitable purposes, or to such organizations or organized and operated exclusively for such charitable purposes, as said curt shall determine.
