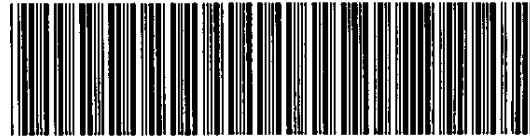

Said organization is organized exclusively for charitable, religious, educational , and scientific purposes, including, for such purposes the making of distributions to organization that qualify as exempt organizations under section 501c3, of the Internal Revenue Code or corresponding section of any future federal tax code. b. Upon the dissolution of the organization, asset shall be distributed for one or more exempt purposes within the meaning of section 501c3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purpose or to such organizations, as said Court shall determine, which which are organized and operated exclusively for such purpose.....
