Pursuant to Chapter 617 of the Florida Statutes (F.S.) the following Articles of Incorporation are set forth.

ARTICLE I: NAME

The name of the corporation shall be **PARTNERS FOR AMERICAN VOCATIONAL EDUCATION, INC.**

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE

The purposes for which this corporation is organized are to:

1. Create and manage partnerships between industry and education for customized training and supportive services.




