**ARTICLES OF INCORPORATION
OF
LOVE & GRACE FELLOWSHIP OF KISSIMMEE, INC. Matthew 6:33**

PREAMBLE – this document sets forth the organizational and basic precepts for operation of a church promulgation the teaching of Jesus Christ by LOVE & GRACE FELLOWSHIP of KISSIMMEE, INC., which has been organized as a not-for-profit corporation under the laws of the State of Florida. In Compliance with Chapter 617, F.S. (not-for-profit)

ARTICLE I

The church shall be known as Love & Grace Fellowship of Kissimmee and shall maintain devotional services and facilities in Kissimmee, Florida and on home and foreign lands.

ARTICLE II

The principal place of business and mailing address of this corporation shall be 2546 Don Jay Ave. Kissimmee, Florida 34741 and the mailing address is P.O. Box 423133 Kissimmee, Florida 34742-3133

ARTICLE III

The controlling tenets of the church are found in the full gospel teachings as set forth in the Articles of Faith, appended hereto. Recognizing that the acceptance of these will cure spiritual and social ills, all activities undertaken in the name of the church shall be directed solely to the propagation and dissemination of the gospel of Jesus Christ, through the preaching, teaching, and examples of lives fulfilling these gospel teachings, as opposed to activities which seek to impose such teachings through civil process or through opposition to civil authority. Notwithstanding this limitation, church members and officers shall be free to express their opinions, on social and political matters, as they may see fit, but as individuals, without reference to their church affiliation.

ARTICLES IV

The church shall be under the leadership of a Pastor. The Pastor shall serve as the statutory president of the not-for profit corporation.

A Board of Elders shall serve the statutory function of Trustees and shall be the representatives of the church body corporate for all legal and purpose.

The authority of the Elders may be subject to membership concurrence, or approval, as provided herein or in the by-laws of the church.

There shall be a minimum of four Elders. The Pastor shall serve as elder and as Chairman of the Board of Elders. The remaining Elders shall be elected by the church membership pursuant to the by-laws of the church.

The elders shall appoint a Secretary, Treasure, and such other officers as may be required from time to time to carry out the purpose of the church.

An Elder may also serve as an officer and a person may hold more than one office. The Pastor and Elders and other officers, presently serving in such capacities, shall continue to serving until their successor are named, or elected pursuant to the provisions hereof and of the by-laws.

ARTICLE V

Church membership shall be open to all persons who are members of the body of Christ, who publicly accept the referenced Articles of Faith, and who pledge their efforts to support Love & Grace Fellowship of Kissimmee. Church membership shall also be conditioned upon a finding by the Elders that the person seeking membership has attained an age of reason and fully understand the Articles of Faith.

The founding membership of the church shall comprise those persons nominated by the then trustees, who thereupon accept membership by pledging their efforts to support the purposes of the church.

A church member shall have voting rights when he/she has reached the age of eighteen years and has evidenced their support of the church purposes, pursuit to then existing guidelines, as they may be set forth in the by-laws.

Church membership prior to the age of eighteen shall be open to those meeting the heretofore-delineated criteria with the exception of right to exercise voting rights in matters before the body.

A roster of church members shall be maintained, indicating the status of each member.

ARTICLE VI

The members of the church having voting rights, at a meeting duly convened, shall decide all matters subject to decision by the membership.

There shall be an annual meeting within two weeks of the anniversary of the first worship services of the church on January 13, 2002. Thereafter, commencing in 2003 the annual meeting shall be held in the month of January, and all elections shall be held at such annual meetings, the

first election being in January of 2003.

The Elders shall set the time and place of the annual meeting and such other meetings as are called, for any matter to be decided by the membership. Notice shall be given of the calling of each meeting and the agenda to be considered.

ARTICLE VII

In the event that this church ceases to be active in carrying out the purposes stated herein, the Elders shall dissolve the corporation and any remaining assets shall be turned over to a religious, educational or charitable organization, selected by the Elders, whose objectives are in harmony with the purposes stated herein. Such recipient organization, or organizations must also be exempt from Federal Income Taxation under the provisions of Section 501 (c) (3), or as that section may be amended. In no event may any of the assets of this church, upon dissolution thereof, be paid to or insured to the benefit of any individual member, director, or officer of this church or any other private individual.

ARTICLE VIII

The Elders are authorized to accept gifts and donations in behalf of Love & Grace Fellowship of Kissimmee, Inc. made for designated purposes and shall comply with the stated conditions, as trustees, of the giver or donor. Provided, however, that the Elders may refuse to accept gifts or donations which they find do not serve the stated purposes of the church, or where they feel that the conditions applicable to the gift or donation are unsuitable to the purposes of the church.

ARTICLE IX

This Articles of Incorporation may be supplemented by by-laws, but shall be controlling as to any inconsistencies therewith.

This Articles of Incorporation may be amended by a two-thirds vote of the Elders, upon approval by two-thirds vote of the membership.

The By-laws may be amended by a majority vote of the membership.

ARTICLE X



This Articles of Incorporation constitutes the regulations of the corporation and replaces all regulations previously adopted.



