

ONE: The name and address of this principal corporation is Anita Victoria Lowe Ministries, Inc. 4768 B Orleans Court. West Palm Beach Florida 33415. The corporation is organized pursuant to the **FLORIDA** Nonprofit Clorporation Code.

Two: This corporation is a non-profit religious benefit corporation and is prganized to spread the gospel of Jesus Christ. The corporation is organized under the Non- profit Public Benefit Corporation Law for Religious purposes. To establish structured support service for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). SEVEN:


