The undersigned, acting as Incorporators) of a corporation Pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

## ARTICLE I Name

The name of the corporation shall be:

## ARTICLE II Principal place of business and mailing address

## ARTICLE III Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

The purpose for which the corporation is organized is to won and operate a 24 hour Flagship Gospel Radio Station in the Tampa Bay Area and to own and operate other electronic Communication Media for the furtherance of the Gospel Music Arts and the Teaching and Preaching of God's Holy Word.

## ARTICLE IV Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

All directors will be elected by the Board of Directors and approved by the shareholders.

**ARTICLE VII**  
**Board of Directors**

The Board of Directors shall have no less than three (3) members and no more than eleven (7) members. A quorum for the Board of Directors is 50% plus one. There shall be four (4) permanent Board of Directors members, which are the initial Board of Directors. See Article XI for the names of the permanent Board of Directors members, also known as Incorporators. There shall be three (3) non-permanent Board of Directors with a term of office of four (4) years with no maximum number of years.

**ARTICLE VIII**  
**Board of Directors Rights of Succession**

The permanent Board of Directors member's seat shall continue at that permanent Board of Directors member's pleasure.

**ARTICLE IX**  
**Associated Board of Directors**

The Associated Board of Directors shall have no less than three and not more than 11 members. The Associated Board of Directors shall make recommendations to the Board of Directors to assist them in decisions that affect the company. The Associated Board of Directors term of office shall be four years. The maximum number of years an Associated Board of Directors can serve is 12.

**ARTICLE X**  
**Number of Authorized Shares**

The number of shares authorized by the Board of Directors is 1,000,000 shares. The initial Board of Directors shall own Fifty one percent of all shares.

**ARTICLE XI**  
**Moral Behavior**

The moral behavior of Board of Directors members, Committee members, paid staff or volunteers shall be governed by the Holy Bible Galatians 5:16-26. Any disagreement or actions of correction within this corporation shall be handle as prescribed in the Holy Bible St. Matthews 18:15-17.
