ONE:

The name of the corporation is N. J. T. MINISTRIES, INC. The principal place of business and mailing address of the corporation is 7002 M.L.K. Blvd., East, Tampa, Florida 33619. The corporation is organized pursuant to the Florida, Nonprofit Corporation Code.

TWO:

This religious corporation is a person authorized to transact business, no one may have it's name or same name, it can sue, borrow, file bankruptcy and more. This corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. The corporation is organized under GOD in which we trust. Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
