

ARTICLES OF INCORPORATION

OF

Q.U.I.E.T., INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, Florida Statutes Chapter 617, and other laws of the State of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation is Q.U.I.E.T., INC.

ARTICLE II

Principal Office

The principal place of business and mailing address of this corporation shall be 9280 Heckscher Drive, Jacksonville, Florida 32226.

ARTICLE III

Purposes

The specific purposes for which the corporation is organized are:

1. To promote the elimination of noise pollution, property damage created by excessive vibration, and the environmental impact on sensitive ecological and residential areas located along the St. Johns River within Duval County created by flights of fixed and rotary winged aircraft over

these areas.

2. To promote study and scientific research into the impact of the noise and excessive vibration from over flights of aircraft on the inhabitants of residential areas, environmentally sensitive wetlands, and wildlife nesting and habitat sanctuaries.

3. To promote study and scientific research into the impact of fuels and other debris from over flights of aircraft on the inhabitants of residential areas, environmentally sensitive wetlands, and wildlife nesting and habitat sanctuaries.

4. To conduct any other related activity permitted under the Not for Profit Corporation Act of the State of Florida and the laws of the United States of America.

All of the foregoing in this article shall be construed as both objects and powers. The enumeration of specific powers and purposes is not intended to restrict or limit in any way the powers or purposes of this corporation.

ARTICLE IV

Term of Existence

The corporation shall have perpetual existence.

ARTICLE V

Registered Agent

The address of the initial registered office of this corporation is 8810 Goodby's Executive Drive, Suite A, Jacksonville, Florida 32217. The name of the initial registered agent at that address is Louis A. Frashuer, Attorney.

ARTICLE VI

Manner of Election of Directors

The business of the corporation shall be managed by its Board of Directors. The Board of Directors shall consist of at least four members. Each member of the Board of Directors shall be elected by a majority vote of the corporation's members. Procedures for the election of Directors and qualifications for membership in the organizations shall be stated within the By-Laws of the Corporation. 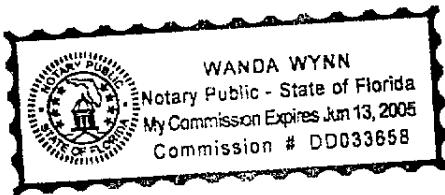


