

Articles of Amendment to Articles of Incorporation  
Spencer Crawford Children's Foundation - NO2000002518  
INC.

FIRST:

Amend Article II and Article V

to reflect the new suite number within the address of the principle place of business, mailing address of corporation and address of the registered agent as follows:

9900 West Sample Road, Suite 405, Coral Springs, Florida 33065

Add Article VIII

Dissolution Clause:

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner or to such organization or organizations organized and operated exclusively for the charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is located, exclusively for such purposes or to such organization or organizations as said court shall determine which are organized and operated exclusively for such purpose.
