## ARTICLES OF INCOPROTATION

The undersigned, acting as incorporator (s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s)  
Articles of Incorporation:

### ARTICLE I

The name of the Corporation shall be: Burning Bush Evangelistic association Inc.

### ARTICLE II

The principle place of business of this corporation shall be:

Burning Bush Ministry Inc.

### ARTICLE III

The specific(s) for which the corporation is organized is (are):

Burning Bush Ministry Inc. is specifically organized as a non-profit independent Christian fellowship (church) with the purpose of spreading the gospel of the Lord Jesus Christ throughout as much of the world as is possible. This corporation will engage in making, teaching, and baptizing disciples into the family of the Almighty God.

### ARTICLE IV

The manner in which the director is (are) elected or appointed is as follows:

The Evangelist of the corporation shall remain in office for as long as the Divine call of God is upon them. The Evangelist is appointed as President of the Corporation. Other officers and/ or directors shall be appointed as needed by the leadership and calling of the Holy Spirit of God. Expansion of Article IV can be found in the corporation by-laws.

### ARTICLE V

The Evangelist of the Corporation shall be responsible for managing the affairs of the corporation. By-Laws of the corporation are to be made by the evangelist with the assistance, when needed, of other board members. Board members shall consist of persons elected and/ or appointed from the membership at the direction of the evangelist. Proposed by-laws shall then be altered, rescinded or voted into law by a majority vote of those members.
