**ARTICLES OF INCORPORATION OF**  
***Voice of Life International Ministries, Inc.***

**A NOT FOR PROFIT ORGANIZATION**

We, the undersigned do hereby join together in the formation of a non-profit corporation,  
following the terms and conditions to wit:

**ARTICLE I**

The name of the corporation shall be:  
***Voice of Life International Ministries, Inc.***

**ARTICLE II**

**Principal Place of Business:**

The principal place of business for this Florida Corporation shall be 3501 Townsend Blvd. # 134, Jacksonville, Florida 32277. The address of the principal office may be changed in accordance with the desires of The Pastor, but under no circumstances will the principal office be located outside of the State of Florida.

**ARTICLE III**

**Nature of Business:**

This corporation is a not for profit corporation, organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this corporation is to operate as a Spiritual/Religious Institution (Church) that ushers believers and non-believers alike, into their rightful 'Kingdom Identity'. The activities conducted are strictly religious, educational and/or charitable in nature, as defined under code 501(c)(3) of The Internal Revenue Service Code.

**ARTICLE IV**

**Terms of Existence:**

This corporation is to operate perpetually, with the effective start of business to begin immediately upon the filing of this document.

**ARTICLE V**

**Stock:**

This corporation will not own capital stock.

**ARTICLE VI**

**Directors/Officers:**

A Board of Directors shall manage the activities and affairs of the corporation. The number of directors which shall constitute the entire board, shall be arranged in the manner set forth in the by-laws of the corporation and/or by Pastoral Appointment, but under no circumstances will the board consist of less than (3) members.

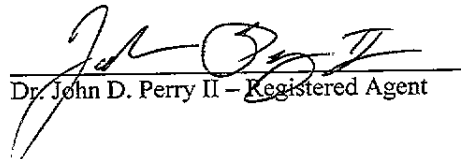

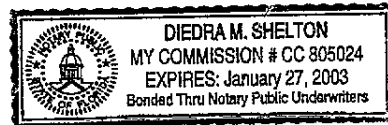
