Article IV - Purposes

The purposes for which the corporation is organized are:

1. To make the public aware of the fact that in states without a Right to Work law like Florida's, workers are being required, against their will, to join and pay dues to labor organizations in order to maintain their employment and earn their living, and to oppose any efforts to repeal Florida's Right to Work Law;
2. To make the public aware of the fundamental rights which are violated by compulsory unionism;
3. To educate the public as to the above issues, and other issues of public concern within the Corporation's general purposes, so that the public may participate meaningfully in dialogue and debate over said issues and so the public may make its preferences known to legislators and governmental officials;
4. To provide testimony at hearings before governmental agencies, commissions, legislative bodies, committees, and at other public bodies as to the issues and objectives described above; and
5. To engage in any lawful act or activity in furtherance of these purposes for which a nonprofit corporation may be organized under Florida law and Section 501(c)(4) of the U.S. Internal Revenue Code.
