The undersigned incorporator, desiring to form a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the corporation shall be: **KINGDOM LIFE INTERNATIONAL MINISTRIES, INC.**

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation shall be:

**ARTICLE III**  
**PURPOSES**

The purposes for which the corporation is organized are exclusively religious, charitable, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding provisions of any future United States federal tax code.

1. **KINGDOM LIFE INTERNATIONAL MINISTRIES, INC.**, is organized exclusively as a church promoting the advancement, goals and ideals of Christianity. In addition, **KINGDOM LIFE INTERNATIONAL MINISTRIES, INC.**, purpose is;
  - a. To provide spiritual training to our members and missionaries.
  - b. To promote strong moral character
  - c. To provide a place and atmosphere to worship GOD.
2. **KINGDOM LIFE INTERNATIONAL MINISTRIES, INC.** is also organized for the purpose of providing social services as part of the church ministry.
  - a. To provide comprehensive counseling and spiritual guidance to low-income, and at risk youth, ages six through adulthood.
  - b. To provide shelter, food, financial support and other needs to low income, and at risk youth, ages six to adulthood.
  - c. To assist and guide low income, and at risk youth in their spiritual, educational, emotional and personal development and growth.
  - d. To provide other assistance, opportunities, programs, activities and events

necessary and relative to the overall principles for maintaining a spirit-filled life and the restoring of families.

- e. To provide comprehensive counseling and spiritual guidance to broken and at-risk men, ages eighteen and beyond.
- f. Allow to receive Loan(s), or Grants, to function program(s) also for the betterment of the church.
- g. To perform and/or provide any other services allowed under Florida law.

#### **ARTICLE IV - MANNER OF ELECTION OF DIRECTORS**

The name in manner which the directors are elected or appointed is:

(1) The corporation shall be governed by an initial board of directors consisting of No less than three members. Directors shall be appointed by the board members on an annual or as-needed basis, not to exceed a total board of five members.
