The undersigned person, desiring to form a Corporation not-for-profit under Chapter 317 of Rical Florida Statutes, certifies as follows:

ARTICLE I

The name of the Corporation is UNIVERSITY OF ST. AUGUSTINE CENTRE FOR RESEARCH, INC.

Purpose

The Corporation is organized for any lawful purpose or purposes authorized by the non-profit corporation laws of the State of Florida, including without limitation the sponsorship of health sciences research. In furtherance of such purposes, the Corporation shall have and may exercise any and all powers, rights and privileges which a corporation organized under the non-profit corporation laws of the State of Florida by law may now or hereafter have or exercise.

ARTICLE III Membership

The Corporation shall have a membership distinct from its Board of Directors. The authorized number and qualification of the members, the manner of their admission, the different classes of membership, if any, the property, voting, and other rights and privileges of members, their liability for dues and assessments and the method of collection thereof shall be as set forth in the bylaws.

ARTICLE IV Existence

The Corporation shall have perpetual existence.

ARTICLE VI Board of Directors

The Articles may be amended at any annual meeting of the Corporation, or at any special meeting duly called and held for such purpose, on the affirmative vote of two-thirds (2/3) of each class of members existing at the time of and present at such meeting. Amendments to the Articles of Incorporation may also be proposed by any Director and may be adopted at any annual or special meeting of the Board of Directors by two-thirds (2/3) vote of the Board members present.

ARTICLE X Amendments to Bylaws

Amendments to the bylaws of the Corporation may be proposed by any member of the Corporation. Such amendments may be adopted by the Board of Directors at any annual or special meeting by two-thirds (2/3) vote of the Board members present.
