*The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:*

## ARTICLE I NAME

The name of the corporation shall be: **CORNERSTONE ACADEMY INC.**

## ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

To properly educate within the guidelines of academic excellence, students in an atmosphere sound fundamental, Christian principles and moral character. Said Academy is organized exclusively for educational, charitable and religious purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. To provide programs for students of all ages that te them skills applicable to advanced education as well as basic life skills applicable for making sound deci sions in their own futures.

Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to members, trustees, officers, or other private persons, except that the organization shall be authorized a empowered to pay reasonable compensation for services rendered and to make payments and distribu tions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the ac ties of the organization shall be the carrying on of propaganda, or otherwise attempting to influence leg lation, and the organization shall not participate in, or intervene in (including the publishing or distribu tions of statements) and political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any othe activites not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future tax code, or (b an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenu Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt pur poses within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section any future Federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court Common Pleas of the county in which the principal office of the organization is then located, exclusiv for such purposes or to such organization of organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


