Purpose:

Women To Women Heart To Heart Make The Connection Ministries, Inc is an evangelistic outreach ministry established to minister to the broken hearted, the down trodden, those bruised by life situations and circumstance, restore the wasted places and set the captives free through preaching and teaching the word of God.

The ministry will function as an outreach; reaching out specifically to woman with children. We shall provide services to women that focus on strengthening families and building community relationships by providing a host of programs and family services through our agency or linking with other organizations that will help to empower and encourage women to be all that God created to be.

This corporation is organized exclusively for charitable, educational, and religious purposes within the meaning of section 501 (c) 3 of the Internal Revenue Code.

Inurement of Income:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, directors, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered.

Legislative or Political Activities:

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation. The corporation shall not participate in or intervene (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Operational Limitation:

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under section 501 (c) 3 of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions, to which are deductible under section 170 (C) (2) Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law).

Dissolution Clause:

Upon the dissolution of the corporation, the Board of Directors shall after paying or making provisions for the payment of all liabilities of the corporation, dispose of all assets of the corporation exclusively for the purpose of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, or religious purposes as shall at the time qualify as an exempt organization or organizations under the section 501 (c) 3 of the Internal Revenue Code of 1986 (corresponding provisions of any future United States Internal Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
