ARTICLES OF INCORPORATION

(In compliance with Chapter 617, F.S. (Not for Profit)

THRONEROOM (TRUST) PRAYER MINISTRY, INC.

MISSION STATEMENT

To promote the advancement of the Christian faith in a holistic manner, thereby bringing biblical principles into the complete fabric of our communities and societies.

PREAMBLE

"The time is fulfilled and the Kingdom of God is at hand ... Worship God for the testimony of Jesus is the Spirit of prophecy."

Mark 1:15 Rev. 19:10c Isaiah 53 Luke 21:22 Ezekiel 2:1-5

Therefore we, the several persons whose names appear upon the membership roster of this ministry, in order to establish and maintain a place for the central location of offices to carry out the mandate for the training of watchmen and intercessors, and the implementation of the ministry of such, do hereby recognize ourselves as a bona fide prayer ministry training and implementation office to carry out the mission of our preamble. We desire to make provisions for people of like faith, lifestyle, and vision to assemble in the name of our Lord Jesus Christ, in fellowship with one another to worship the one true God, Jehovah, and His Son the Lord Jesus Christ, through the Person of the Holy Spirit; to be trained as watchmen to pray and intercede for individuals, churches, cities, states, nations/countries; to proclaim and respond to God's Holy Word according to our distinctive testimony and to assume our share of responsibility and privilege of propagating the gospel of Jesus Christ both at home and abroad. Therefore we do adopt the following articles of order and submit ourselves to be governed by them.

ARTICLE I: NAME

The name shall be THRONEROOM (TRUST) PRAYER MINISTRY, INC

ARTICLE II: PRINCIPAL OFFICE

The <u>Principal office</u> of the ministry shall be 3200 Apalachee Parkway, Tallahassee, Florida 32311.

The Mailing address of the ministry shall be P. O. Box 5845, Tallahassee, Florida 32314.

ARTICLE III: PURPOSE

The ministry is called and established by God as a Prophetic Prayer Ministry:

- a) To carry out the responsibilities as prescribed by God's Holy Word of being a Watchman, proclaiming and declaring the will and destiny of the Lord so that people, countries/nations, cities, states, etc. will fulfill God's eternal destiny for them. Isaiah 62:1-7; Exodus 33:1-9; Daniel 9; Acts 24:17; Nehemiah 1; Ezekiel 2:1-5
- b) To watch over the Church (the body of Christ or the bride of Christ) by interceding in her behalf so that she will fulfill her role in prophecy; to declare the will of the Lord to her in order to bring a clear call to her to be ready for

the rapture and the coming of her Bridegroom, the Lord Jesus Christ. Joel 2; Isaiah 4:2

- c) To help the Church find her purity, direction, and focus to prepare the way or be used by the Holy Spirit to create the environment for the coming of the Lord Jesus Christ.
- d) To fulfill the Great Commission through prophetic evangelism and missions. Luke 21:22; Matthew 24:14; Ezekiel 37
- e) To be used by the Lord just as Elijah, Daniel, Nehemiah, and John the Baptist and many other noteworthy prophetic people in scripture were used to minister to their generation, so do we want to be used in our generation.

ARTICLE IV: MANNER OF ELECTION

A. <u>BOARD OF DIRECTORS.</u>

The spiritual and temporal government of this ministry shall be vested in the Board of Directors. This board shall comprise of the minister-in-charge (the incumbent), or whatever official designation or title, and not more than seven members and not more than five other members to be elected at the annual general meeting who shall hold office from the conclusion of that meeting.

Section 1: The Board of Directors may in addition appoint not more 2 co-opted members but so that no-one may be appointed as a co-opted member if, as a result more than one third of the Board of Directors would be co-opted members. Each appointment of a co-opted member shall be made at a special meeting of the Board of Directors called under clause I and shall take effect from the end of that meeting unless the appointment is to a place which has not then been vacated in which case the appointment shall run from the date when the post becomes vacant.

<u>Section 2:</u> Half of the members of the Board of Directors shall retire from office together at the end of the annual general meeting next after the date on which they came into but they may be re-elected or re-appointed.

<u>Section 3:</u> The proceedings of the Board of Directors shall not be invalidated by any vacancy among their number or by any failure to appoint or any defect in the appointment or qualification of a member.

<u>Section 4:</u> Nobody shall be appointed as a member of The Board of Directors who is aged under 18 or who would if appointed be disqualified under the provisions of the following clause.

<u>Section 5</u>: No person shall be entitled to act as a member of the Board of Directors whether on a first or on any subsequent entry into office until after

signing in the minute Book of the Board of Directors a declaration of acceptance and of willingness to act in the trust of the charity
