**ARTICLES OF INCORPORATION  
OF**

**ONE:** The name and address of this principal corporation is *Healing The Harvest Ministries, Inc.*, 4770 NW 19<sup>th</sup> Street, Lauderhill, FL 33313, in Broward County. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code.

**TWO:** This corporation is a non-profit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Non-profit Public Benefit Corporation Law for Religious purposes. To license/Ordination of ministries to preach the Gospel of Jesus Christ. To establish structured support service for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the corporation creed/by-laws as a pastor to spread the gospel of Jesus Christ. 
**SIX:** The Directors are elected in accordance with the By-laws. The name and address of the persons appointed to act as the initial Directors of this corporation are:

Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
