ARTICLES OF INCORPORATION

Healing The HARVEST Ministries Inc.

ONE:

The name and address of this principal corporation is Healing. The Harvest Ministries, Inc., 4770 NW 19th Street, Lauderhill, FL 33313, in Broward County. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code.

TWO:

This corporation is a non-profit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Non-profit Public Benefit Corporation Law for Religious purposes. To license/Ordination of ministries to preach the Gospel of Jesus Christ.
